Cryptocurrency Disclosures

The purpose of this form is to outline the unique principles and risks of investing in any models on the Wealth Watch Advisors platform containing a Bitcoin or Ethereum ETF or other ETFs holding companies' stocks in the cryptocurrency ecosystem. The Advisor and Client must sign this document to acknowledge agreement and understanding of the content included in this form before trades will be approved by Wealth Watch Advisors staff.

Bitcoin, Ethereum spot ETFs, or ETFs that hold stocks of companies specific to the cryptocurrency industry, are publicly traded investment funds enabling investors to gain exposure to a specific coin or companies operating within the cryptocurrency ecosystem without owning the coin or directly purchasing the stocks that a specific ETF might hold. Unlike cryptocurrencies on crypto exchanges, ETFs are traded on traditional securities exchanges, such as the New York Stock Exchange and Nasdaq. Since the underlying asset in the ETFs is an investment in a specific coin or company stock, the fund has the same volatility level as direct ownership in a coin or company stock. By choosing to invest in any model on the Wealth Watch Advisor platform that contains Bitcoin, Ethereum, or an ETF that invests in companies within the cryptocurrency ecosystem, the Client and Advisor agree that they fully understand and have discussed the risk, and the added volatility associated with the model.

Any investment of over ten percent (10%) into any of the Wealth Watch Advisor models that hold ETFs in the cryptocurrency ecosystem understands and agrees will substantially increase the risk of the Client's portfolio, which can dramatically impact the value of their portfolio. By signing this Disclosure Statement, the Client understands and agrees that a holding of ten percent (10%) or more adds significant risk to their investment portfolio.

The Client and the Advisor understand that Wealth Watch Advisors is not responsible for policing or enforcing whether the volatility of indirect ownership associated with a Wealth Watch Advisor model is understood outside of requiring a signature on this document. Investment choices that contain a Wealth Watch Advisor model invested in cryptocurrency coins or stocks are ultimately up to the discretion of the Client and the Advisor's shared understanding of the Client's full financial situation and ability to assume market risk.

After reviewing the information above and discussing it with my Investment Advisor Representative, I understand and agree that any model containing spot ETFs or an ETF with holdings related to companies in the cryptocurrency ecosystem is fundamentally different and more volatile than many of the other investment choices available through Wealth Watch Advisors, Inc. that are not invested in the cryptocurrency ecosystem. It has been determined that an investment model containing the WWA Bitcoin Strategic or the WWA Cryptocurrency models is appropriate for my financial situation.
